## SCOPE

The Naval Air Warfare Center- Aircraft Division (NAWC-AD) Cyber Warfare Department has been tasked to develop and sustain a Cyber Supply Chain Risk Management capability for NAVAIR, all subordinate commands, and partner Navy organizations including but not limited to NAVSEA and NAVFAC. This work extends the capabilities developed under US Air Force SBIR topic #AF203-CS01 into a Department of Navy production environment. This contract is a single award indefinite delivery / indefinite quantity (IDIQ) contract for the procurement of cyber supply chain risk management (C-SCRM) software licenses, C-SCRM analysis and reports, and software integration and systems administration support. Specific requirements will be derived from the scope of this statement of work and documented through individual Delivery Orders (DO) or Task Orders (TO).

Each task order must include:

- Order date and task order number
- Description of work and deliverables
- Place of performance
- Period of performance
- Pricing
- Any security or data requirements (like DD Form 254 or DD Form 1423)
- Payment, inspection, and acceptance details
